**FINAL JUDGEMENT ORDER**

THIS MATTER COMING BEFORE THE COURT for prove up pursuant to the Order of Default entered by Court on, April 11, 2005 the Plaintiff being present in open court, due notice having been given to the Defendants and the Defendants failing to appear in court, and the Court being fully informed and advised in the premises;

**THE COURT HEREBY FINDS:**

- A. That this Court has jurisdiction over the subject matter of this action and personal jurisdiction over the parties;
- B. That on April 11, 2005, this Court entered an Order holding Defendants HAIL RESTORATION, INC and ROBERT K. OLSON in default, and set the matter for prove up on April 28, 2005;
- C. That plaintiff's complaint state a cause of action pursuant to the Illinois Consumer Fraud Act, 815 ILCS 505/1 *et seq*; and the Home Repair And Remodeling Act, 815 ILCS 513/1 *et seq*.

D. That defendants HAIL RESTORATION, INC., an Illinois Corporation, and ROBERT K. OLSON, individually and as President of HAIL RESTORATION, INC., in the course of their business, vocation, or occupation, have engaged in conduct violative of the Illinois Consumer Fraud Act and the Home Repair and Remodeling Act.

E. That defendants HAIL RESTORATION, INC., an Illinois Corporation, and ROBERT K. OLSON, individually and as President of HAIL RESTORATION, INC., do not hold nor have they ever held licensure under the Illinois Roofing Industry Licensing Act.

F. That defendants HAIL RESTORATION, INC., an Illinois Corporation, And ROBERT K. OLSON, individually and as President of HAIL RESTORATION, INC., are not nor have they ever been licensed public adjusters.

**IT IS HEREBY ORDERED;**

1. That a permanent injunction is entered against defendants, HAIL RESTORATION, INC., and Illinois Corporation, and ROBERT K. OLSON, individually and as President of HAIL RESTORATION, INC., and each of them, or by any other name or through any other corporation, partnership or business entity in which Defendants have any interest, enjoining said Defendants from engaging in the trade or commerce of advertising, offering for sale, and selling, home repair, improvement, remodeling goods or services in Illinois;

2. A permanent injunction is entered against defendants HAIL RESTORATION, INC., and Illinois Corporation, and ROBERT K. OLSON, individually and as President of HAIL RESTORATION, INC. and each of them, individually, or by any other name or through any other corporation, partnership or business entity in which

Defendants have any interest, enjoining said Defendants from engaging in the business of adjusting insurance claims in Illinois.

3. That a Judgment in is entered for the benefit of Illinois consumers against HAIL RESTORATION, INC., and Illinois Corporation, and ROBERT K> OLSON., individually and as President of HAIL RESTORATION, INC., jointly and severally, in the sum of \$ 574,333.68 as and for restitution. The Attorney General is to distribute the money to consumers harmed by Defendants.

4. That a Judgment is entered in favor of the People of The State of Illinois and against HAIL RESTORATION, INC., and Illinois Corporation and ROBERT K. OLSON, individually and as President of HAIL RESTORATION, INC., jointly and Severally, in the sum of \$ 1,118,000.00 as a civil penalty to Section 7 of the Consumer Fraud Act.

5. This is a final and appealable Judgment an no just reason exists to delay enforcement or appeal.
